Hello Brandon,

Warm greetings from the General Service Office (GSO) of Alcoholics Anonymous (AA) in New York City. My name is Patrick Claymore, and I am a GSO staff member. My current duties include serving the Public Information Assignment. Thank you for writing, I am glad to be in touch.

This is an interesting question. The point of any Public Information outreach and presentation is to carry the message about Alcoholics Anonymous to any third parties who may come in contact with a person who has a drinking problem and to share with them information about A.A. that details that we may have a solution. The solution we offer has helped millions of people.

For A.A.s serving on Public Information (P.I.) committees, this <u>workbook</u> offers shared experience on carrying the message through various media, including print, radio, TV and the Internet, as well as on organizing workshops and creating presentations. Sample letters to various professionals provide additional guidance.

What is Public Information work and Why Should A.A.s Do It?

Public Information (P.I.) in Alcoholics Anonymous means carrying the message of recovery to the still-suffering alcoholic by informing the general public about the A.A. program. We carry the message by getting in touch with and responding to the media, schools, industry, and other organizations which can report on the nature and purpose of A.A. and what it can do for alcoholics.

The first Public Information committee in A.A. was formed by the General Service Board in 1956.

At that time, the following statement of "A.A.'s movement-wide public information policy" was written and approved by the General Service Conference:

In all public relations, A.A.'s sole objective is to help the still suffering alcoholic. Always mindful of the importance of personal anonymity we believe this can be done by making known to him, and to those who may be interested in his problems, our own experience as individuals and as a Fellowship in learning to live without alcohol. We believe that our experience should be made available freely to all who express sincere interest. We believe further that all efforts in this field should always reflect our gratitude for the gift of sobriety and our awareness that many outside A.A. are equally concerned with the serious problem of alcoholism.

As our co-founder, Bill W., wrote: Public Information takes many forms — the simple sign outside a meeting place that says "A.A. meeting tonight;" listing in local phone directories; distribution of A.A. literature; and radio and television shows using sophisticated media techniques. Whatever the form, it comes down to "one drunk carrying the message to another drunk," whether through personal contact or through the use of third parties and the media. The needs and experiences of people in your own area, large or small, urban or rural, will affect what you decide to do.

The suggestions in this workbook are just that — suggestions — to spark your thinking on how best to work at carrying the message.

Other local P.I. Committees have shared a multitude of places that they have presented information about A.A. State fair booths, church health fairs, pride events and numerous types of events that make sense based on the diverse make up of who is around them in their local towns, cities, and neighborhoods.

As participants in any event the A.A. members from the PI Committee need to be very clear about what they are there to talk about, Alcoholics Anonymous.

Some things to consider. We would not want to have our pictures taken at such events with A.A. members identified for a newsletter, website or any social media channel. The way these matters are handled is, the event coordinators can take a picture of a booth with A.A. materials stating that A.A. was present to share about their program of recovery.

We would not want to have A.A. on a T-shirt for an event that showed other sponsors. We couldn't be a sponsor of such events, just participants.

Almost all the events that we carry a PI presentation or participate by having an A.A. booth are almost always non-A.A. events.

It is hoped this information is helpful to you and to your committee.


