Webmaster Report for November 2021 YAI Meeting

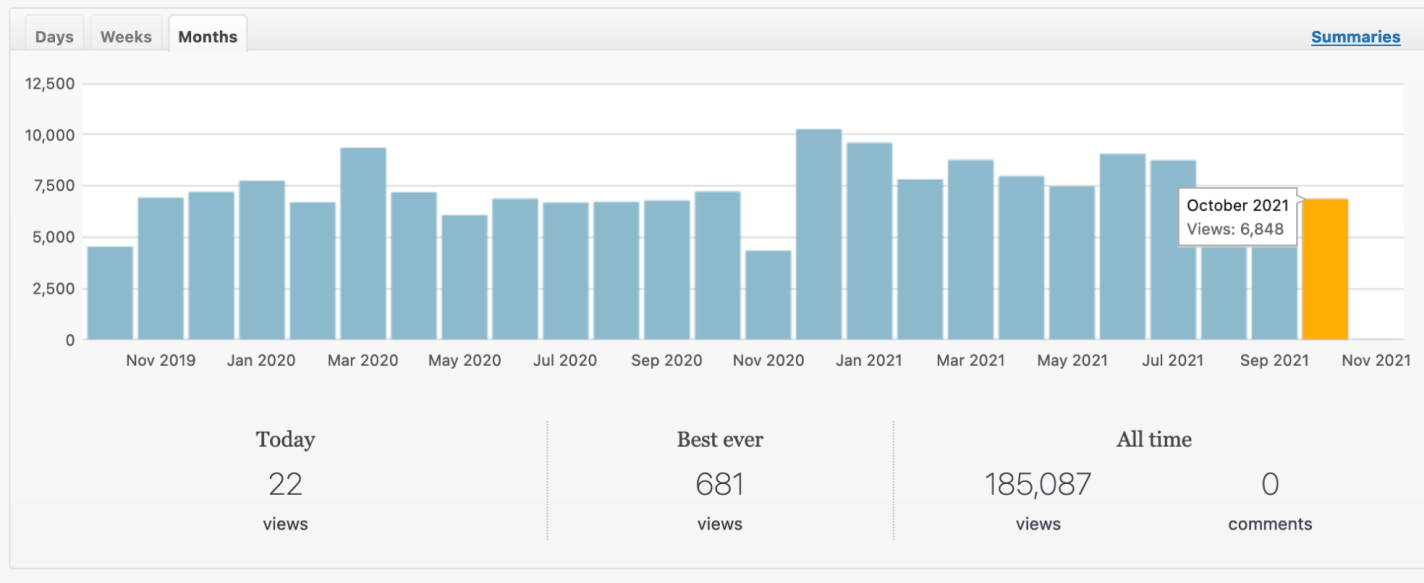
